The building is predominantly of brick construction with a flat roof and mostly two storey. A newer single storey section fronts Salter Street.

The main pedestrian entrance to the property is from Gaolgate Street.

There is a goods entrance via a roller shutter loading door at the northern end of Salter Street, at the junction with North Walls. Staff parking is on the rear boundary of the site, accessed from North Walls.

Trespass clothing store occupies the unit to the left hand side and to the right hand side the unit is currently vacant and available to rent. Nearby retailers include, Go Outdoors, Ryman Stationers and Kutchen Haus.

The site offers good re-development opportunities. Consent was previously granted for a mixed use retail and residential under ref 21/35175/OUT.
